Authority Control and Database Maintenance

December 2024 Authority Control/Batch Deletes

- 17,249 items and 2,053 bibliographic records (with only withdrawn items attached) were deleted in the monthly batch deletion of withdrawn items.
- 3,318 bibliographic records were newly cataloged and/or updated in the database between 11/21/2024 and 12/16/2024.

January 2025 Authority Control/Batch Deletes

- 30,816 items and 6,788 bibliographic records (with only withdrawn items attached) were deleted in the monthly batch deletion of withdrawn items.
- 3,694 bibliographic records with no items attached (that were created before 10/1/24) were deleted from the database.
- 4,409 bibliographic records were newly cataloged and/or updated in the database between 12/18/2024 and 1/28/2025.
